Confirmed Minutes of the Ordinary Parish Council Meeting Held on  
Monday 19<sup>th</sup> February 2024

23-24/81 To receive Apologies:

Apologies: All Councillors present.

23-24/82 To approve the minutes of the Parish Council meeting that took place on Monday 15<sup>th</sup> January 2024.
