The Ward Councillor Jeremy Wilcock is pursuing two enquiries with Yorkshire Water on behalf of the Parish Council.

1. Whether the Chapel Street Pumping station discharged any untreated sewage in 2023 during the periods of flooding.
2. What is the nature of the discharge from the outfall from the WWTP into the Bryan Mills Beck at the bridge by Carriage Drive and is there any risk to health to anyone playing in the beck?

74.3 General Information:

- a) The Ward Councillor reported that ERYC are being squeezed hard with budgets in the forthcoming financial year, with a lack of funding from Central Government.
- b) Devolution – The devolution consultation process is ongoing until the end of February.
- c) Telegraph Poles – There is a big controversy ongoing in ERYC area re erection of telegraph poles to carry fibre optic cable.

75.1 Hornsea 4 – Current status and forward plan.

During the November PC meeting, there was some discussion that the Hornsea 4 Cable Route and the Logistics compound were going to be relocated away from Lockington.

The Clerk has contacted Hornsea 4 and has been told in writing that the cable route and the Logistics Compound route/positions are unchanged.

Logistics compound will be located at the SW corner of the A164 and Station Road cross-roads. The cable route will cross the A164 South of the cross-roads and will also cross Station Road East of the cross-roads.
